

ALBERT PARK TENANT PARKING PERMIT APPLICATION FORM

Albert Park is Melbourne's highest profile park, located just 3 km from the CBD of Melbourne. It is a 225 ha sporting and recreational park that caters for formal and informal recreation. Albert Park is the focus for many of Victoria's spectacular events and is also an important sanctuary for wildlife and vegetation.

Parks Victoria is responsible for the management of Albert Park Reserve. To control the increasing demand for parking within Albert Park, a fee-based parking system will apply to all car parks and kerbside parking spaces within the Park, commencing from February 2006.

To provide discounted parking for legitimate sportsclubs, businesses and tradespeople conducting work within Albert Park, Parks Victoria administers a system of parking permits. By displaying a valid parking permit, permit holders are exempt from a number of parking restrictions.

All profits generated from the modest fees charged for parking and parking permits at Albert Park are spent within the Park to improve park facilities for the benefit of all users.

TENANT PARKING PERMITS

- Exempt Albert Park business owners and their employees from time restrictions and paying relevant parking fees. Proof of eligibility must be provided with the application.
- May only be used for parking in Albert Park whilst the permit holder is actually conducting work in the park.
- Do not exempt the permit holder from Clearways, No Stopping Areas, Loading Zones or parking on parkland and other areas where parking is excluded.
- Do not guarantee that a parking space will be available.
- Are for the use of the applicant specified on this form only.
- Are issued only on the basis that the applicant accepts the permit conditions.
- Are issued for the specified duration only. 6 Months, 1 Year.
- Are only available to business owners and their employees conducting work within Albert Park.
- All holders of Government concession cards will be eligible for 50% discount on the permit. Eligible concession cards are: Pensioner Concession, Senior Health Care, Health Care, and DVA Gold Cards.
- Can be purchased on-site at the Parks Victoria office upon arrival at Albert Park, or can be purchased in advance by completing this application form and mailing it to Parks Victoria as shown overleaf.

Who requires a permit?	<p>Parking fees apply to all vehicles within Albert Park from 8am – 9pm 7 days per week, unless you hold a valid permit.</p> <p>If you are a business owner or employee conducting legitimate work within Albert Park, you will be eligible for a Tenant Parking Permit. If you do not wish to purchase a permit, you will need to use the “pay-and-display” parking machines within the park instead. If you have chosen to purchase a parking permit, it must be displayed on your dashboard at all times between 8am – 9pm, 7 days per week.</p> <p>If you require additional parking spaces for storage of equipment etc. please apply for a Reserved Parking Permit from the Parks Victoria office. If you have plant & equipment that must be stored on parkland or other areas, please contact the local Ranger to receive permission first.</p>
Where can I park?	In any valid parking spaces along the kerbside or in designated car parks in Albert Park Reserve. Where possible, park as close to the facility where you will be doing the activity.
Where can't I park?	You cannot park in Clearways, No Stopping Zones, or on parkland or other areas where parking is excluded. Loading Zones are for short term pick-up/drop off only. Your parking permit does not exempt you from the time restrictions associated with a Loading Zone.
How much does a permit cost?	Tenant parking permits cost \$125 per 3 months, and can be issued for any duration depending on how long your involvement in the park will continue. Permit fees are not refundable, even if your involvement is completed prior to the expiry of the permit.
